for touristic purposes, located in a central, strategic area of Porto, one of the most illustrious cities in the World and the oldest ones in Europe.



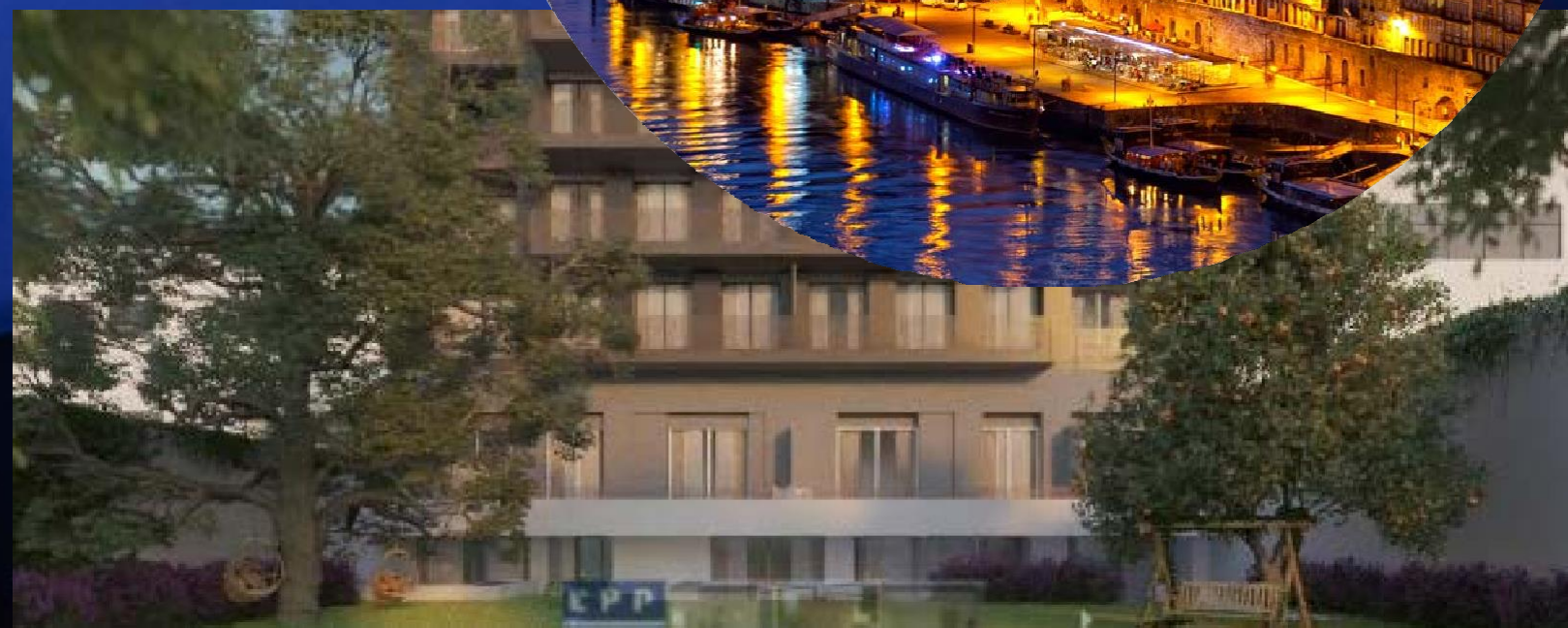
# The Experience

### Year 5

— Golden Visa renewal and application for Permanent Residency\* or Citizenship.

\*A clean criminal record is a condition for the permit issuance.

- Police clearance certificate from country of residence, attested by Portuguese embassy
- Tax number
- Family documentation similar to investor
- Marriage/Birth certificate, attested by Portuguese embassy
- Other documentation on a case-by-case basis
